SUBJECT: Twinning of Highway #16 and BC #5

SUBMITTED BY: Town of Valemount

Whereas highway safety on the TransCanada Yellowhead Highway is a significant concern for residents, businesses, communities and governments in and near the highway corridor; and

Whereas significant losses of life have occurred on the TransCanada Yellowhead Highway between Kamloops and Prince George (Highways 5 & 16) in recent years including three deaths near Valemount, BC in late 2014 - early 2015;

NOW, THEREFORE BE IT RESOLVED: that the TransCanada Yellowhead Highway Association petition the Province of British Columbia to advance the twinning of

Highways 5 & 16 and/or develop additional passing lanes along the highways to improve highway safety in these corridors.

ii. Resolution 2015-2

SUBJECT: Twinning of #16 from Clavet to Saskatchewan-Manitoba border SUBMITTED BY: City of Yorkton

Whereas: The Trans Canada Yellowhead Highway between Clavet and Yorkton is currently an undivided two lane highway;

And Whereas: The Trans Canada Yellowhead Highway is recognized as Canada's national roadway network linking communities and facilitating economic activity and tourism;

And Whereas: There is a recognized value of this highway network to our nation's economy;

And Whereas: The Trans Canada Yellowhead Highway plays an important role in the efficient movement of goods and services and provides a unique and vital tourism experience;

And Whereas: Users of Trans Canada Yellowhead Highway, commercial and personal, expect the same safety of travel as exists on Trans Canada #1; **And Whereas:** A divided highway will enhance safety to motorists;

NOW, THEREFORE BE IT RESOLVED: That the Trans Canada Yellowhead Highway Association advocate to the Province of Saskatchewan and the Government of Canada for the twinning of the Trans Canada Yellowhead Highway between Clavet and Yorkton.

SUBJECT: Trans Canada Highway #16 through Neepawa Manitoba SUBMITTED BY: MB Caucus

Whereas: That portion of the highway thro9ugh Neepawa needs re-doing however scheduling is impacted by the Town's need to carry out municipal infrastur4cure repairs in conjunctions with road rebuilding;

NOW, THEREFORE BE IT RESOLVED: That the Trans Canada Yellowhead Highway Association lobby the Manitoba Government through the Ministry of Transportation to work in conjunction with and in cooperation with the Town of Neepawa so that the highway rebuilding can proceed expediently and considering the interests of all involved.

Whereas: The Yellowhead Highway #16 and BC #5 have been identified as

And Whereas: driver safety on Highway #16 and #5 is paramount;

NOW, THEREFORE BE IT RESOLVED: That the Trans Canada Yellowhead Highway Association advocate to the BC Minister of Transportation to develop a consistent standard of highway maintenance on Trans Canada #16 and BC #5 that is equivalent to the standard used on Trans Canada #1.
